**Item 5.02 Departure of Directors or Certain Officers; Election of Directors; Appointment of Certain Officers; Compensatory Arrangements of Certain Officers.**

On June 9, 2015, Remington Outdoor Company, Inc. (the “Company”), announced a series of changes to senior management and the Board of Directors of the Company (the “Board”):

*Departure of Certain Officers and Directors*

George Kollitides II announced he was stepping down as Chief Executive Officer and Executive Chairman of the Board of the Company, effective immediately. Mr. Kollitides has entered into a one year consulting agreement under which he will serve as a Senior Advisor, providing advisory and transition services to the Company.

Ronald E. Kolka announced he was retiring as the Chief Financial Officer and as a Director of the Board of the Company. Mr. Kolka will remain with the Company for the next 30 days while a search is conducted for a permanent Chief Financial Officer.

Walter McLallen IV and James J. Pike announced their retirement as Directors and Vice Chairmen of the Board, both effective immediately.

*Appointment of Certain Officers*

Jim “Marco” Marcotuli, age 56, was appointed to serve as President, Chief Executive Officer and Interim Chairman of the Board of the Company, effective immediately. Mr. Marcotuli has served as Co-Lead Director of the Board of the Company since September 2014. Mr. Marcotuli has served as a Senior Operating Executive with Cerberus Operations and Advisory Company, LLC, (“Cerberus”) since June 2014. Prior to joining Cerberus, he served as President and CEO of North American Bus Industries, a previous Cerberus portfolio company from 2009 to 2013.

*Election of Directors*

Jeffrey P. Pritchett was appointed to serve as a director of the Board of the Company, effective immediately. As a member of the Board, Mr. Pritchett will also work with Mr. Kolka through the CFO transition period. Mr. Pritchett joined Cerberus as a Senior Operating Executive in 2013 and was promoted to Head of the Finance/CFO Practice in 2015. Prior to joining Cerberus, Mr. Pritchett served as Senior Vice President and Interim CFO of Vertis Communications from 2007 to 2013. Mr. Pritchett also has held leadership roles at Delphi Corporation, Hewlett-Packard and General Motors. Mr. Pritchett received a Bachelor of Business Administration in Finance and Economics from Walsh College and a Master of Business Administration from Purdue University – Krannert School of Management.

James P. Campbell, who has served as Lead Director of the Board since April 2012 and as Co-Lead Director of the Board since September 2014, was appointed Vice Chairman of the Board. The Company has also initiated a search for a Chairman of the Board.
